Defence of the proposal should demonstrate a basic overview of translation theory and research methodology in the field. Estimated scope of the project: 9,000-11,000 characters (including spaces).

Applicants are welcome to present their own projects outside the research areas outlined above, as long as they focus on European languages and cultures; however, we strongly advise applicants to consult the Programme Director and the prospective supervisor on such topics in advance.
